Subject: - Allocation of budget under ARM/SR for Revised Estimates 2024-25 and Budget Estimates 2025-26-reg.

Sir/Madam,

I am directed to inform that the Standing Committee has approved the allocation of a sum of **Rs. 41411 lakhs** and **Rs. 10654 lakhs** under the Sub – Head “Hospital/Dispensary” and “Office Building” respectively for the purpose of ARM and a sum of **Rs. 27244 lakhs** and **Rs. 7944 lakhs** under the Sub – Head “Hospital/Dispensary” and “Office Building” respectively for the purpose of SR during the year 2024-25. Likewise, a sum of **Rs. 48072 lakhs** and **Rs. 12249 lakhs** has been allocated under the Sub-head “Hospital / Dispensary” and Office Building” respectively for the purpose of ARM and a sum of **Rs. 33037 lakhs** and **Rs. 9264 lakhs** under the Sub – Head “Hospital/Dispensary” and “Office Building” respectively for the purpose of SR during the year 2025-26. The Regional Office / Hospital wise distribution of this amount has been shown in the enclosed statement (Appendix- ‘G’ & ‘H’).

You are requested to sanction and release the funds under your delegated powers in accordance with the detailed guidelines issued from time to time. The request/indent for transfer of funds so sanctioned should be sent directly to Finance & Accounts II at Hqrs’ Office under intimation to Property Management Division. It may please be ensured that the funds are remitted to the maintenance agencies at the earliest possible.

Further, if there is any demand under ARM/SR for the financial year 2024-25, the demand with all details and justification for such additional demands may be sent to the PMD, Hqrs. As regards, additional demand for the financial year 2025-26, the same may be sent while submitting revised budget estimates for the financial year 2025-26 by 31st August 2025. No further request for ARM/SR will be entertained after that period and the present allocation would be treated as final.

The allocation is subject to approval of the revised estimates 2024-25 and budget estimates 2025-26 of ESIC Corporation from the Central Govt. If there is any urgent addition requirement of ARM/SR funds for 2025-26, the same may be intimated with all details / justification to Hqrs. Office for consideration/allotment.
